

CITY COUNCIL WORKSHOP MEETING MINUTES April 17, 2024

The City Council met for a Workshop Meeting at 4:00 p.m. City Hall 102 Butler St., Saugatuck, MI 49453.

Call to Order:

The meeting was called to order by Mayor Stanton at 4:00 p.m.

Motion by Baldwin, second by Anderson o change line item eight to motion to move into a closed session pursuant to MCL one 5.268 II to consult with the city attorney regarding trial strategy regarding the lawsuit filed against the city by Maplewood hotel, caption Maplewood hotel Corporation versus City of Saugatuck and interim city manager Ryan comments. Public Comment:

Dan Fox, resident: suggested there be a clarity up front on any water surcharge that may be implemented in the future.

Gary Medler, resident: opposed of spending more money on another study on Park Street. Suggested on doing small portions of the street every year.

Motion by Dean, second by Baldwin to move into closed session pursuant to MCL 15.268(e) to consult with the city attorney regarding trial strategy regarding the lawsuit filed against the city by maple wood hotel captioned Maplewood hotel Corporation versus City of Saugatuck and interim city manager Ryan comments case number four Dash 68795-CZ because discussing the pending litigation in open session may have a detrimental financial impact on the city. Via roll call vote, motion carried 6-0.

Motion by Muncey, second by Garnder to allow our city attorney to execute the settlement agreement between Maplewood Hotel corporation and the City of Saugatuck as stated. Via roll call vote, motion carried 6-0.
