

# CITY COUNCIL WORKSHOP MEETING MINUTES October 18, 2023

The City Council met for a Workshop Meeting at 4:00 p.m. City Hall 102 Butler St., Saugatuck, MI 49453.

## 1. Call to Order:

The meeting was called to order by Mayor Dean at 4:00 p.m.

## 2. Attendance:

Motion by Baldwin, second by Gardner to excuse Stanton, Lewis and Leio from today's Council workshop. Via voice vote, motion carried 4-0.

<u>Others Present:</u> City Manager Heise, Director of Planning, Zoning, & Project Management Cummins, Treasurer Stanislawski, City Attorney Witte, Clerk Wolters.

**3. Agenda Changes:** Councilmember Gardner requested to include a brief discussion about Friday's open house for the airport property.

Motion by Garnder, second by Muncey to include the airport property as 6D. Via voice vote, motion carried 4-0.

## Dan Fox, resident:

Council representative to the Fire District Board. He noted he will not be in attendance for the City Council meeting on Monday. He will send Clerk Wolters a report to include in the packet.

## 6. Discussion Items:

Discussion of Playground Naming- Bekken-

Councilmember Gardner mentioned the following:

- Mark Bekken is the longest serving Council member with 42 years of service.
- He is a big sports enthusiast.
- A multipurpose court should be named after him.
- Asked if there was a policy on Park naming. There should be a policy put in place for the future if one is not existing.

Treasurer Stanislawski wasn't aware if there is a policy on naming parks in the City. Councilmember Muncey asked if there was a policy when Jones Park was named. Mayor Dean asked City Manger Heise to bring recommendations in term of a policy. He would like DPW to assist on when they will be updating the basketball court, so it is in pristine shape for dedication and the right time of year.

Councilmember Garnder would like to see this topic at the first workshop in November. Mayor Dean will leave it up to City Manager Heise to judge when he can bring it to a workshop.

April Gundy submitted a permit application to hang a banner on the Saugatuck palette sign to promote the Ugly Sweater Pub Crawl to take place on 12-2-23.

#### ODC Open House for Airport Property:

Councilmember Gardner asked for details about an open house on Friday by the ODC called SOAR.

Councilmember Baldwin who is the chair of the Parks and Public Works Committee explained that it is a public meeting to analyze strengths, opportunities, results, and aspirations. It is open for the public to make comment about what they think would e great at the property.
