A. Resolution 230911-A- Extending Waterfront Moratorium -

Ryan Cummins-

- In March Council passes an initial ordinance enacting a moratorium in the Water Street South, Water Street North, and Resort Zoning Districts.
- The Planning Commission has been making progress evaluating zoning regulations.
- The Planning consultant has provided an initial assessment report that the Planning Commission and Historic District Commission discussed and provided feedback.
- Two separate surveys were sent out to community members.
- The Planning Commission will have a public hearing in October.
- The moratorium is currently set to expire on September 30, 2023. The moratorium ordinance provided City Council may extend the moratorium by resolution.
- Ask is to extend the moratorium through December 31, 2023.
