SUBJECT:	Resolution No. 231211-B, A Resolution Extending the Temporary Waterfront Commercial Development and Construction Moratorium

# **DESCRIPTION:**

After recommendations from the Planning Commission, the City Council enacted a temporary moratorium, through the adoption of Ordinances No. 230612-A and No. 230322-B, on Waterfront Commercial Development and Construction within the City. This includes new site developments including parking and site improvements, new building construction, and existing building expansion in the Waterfront Commercial Temporary Moratorium Area.

Since the moratorium was enacted, the Planning Commission has made good progress on the waterfront assessment project:

- April A kickoff meeting was held with Planning Consultant, David Jirousek, and the Planning Commission to discuss project scope.
- May and June Survey designs and study of the area.
- July Extensive public engagement was conducted with two surveys and pop-up events with poster boards. The Planning Commission reviewed and provided feedback on assessment report.
- August, September, and October Planning Commission considered options and finalization of recommendations.
- November Planning Commission held a public hearing and deliberated on the draft changes.

The Planning Commission will have further deliberations on a recommendation to Council at their December meeting. After a recommendation is received from the Planning Commission, the City Council will then review and make a decision on the recommendations. This will likely take another two to three months to accomplish.

The moratorium ordinances provide that the City Council may extend the moratorium by resolution from time-to-time to finish adopting new regulations governing uses in moratorium area. The City Council approved an extension in September through the end of December. Extending the moratorium

through March 31, 2024 will ensure the City has sufficient time to adopt new regulations governing uses in the moratorium area.

**LEGAL REVIEW:** The City Attorney prepared the resolution to extend the moratorium. The City Attorney will be at your meeting to answer any questions you may have.

# A RESOLUTION EXTENDING THE TEMPORARY WATERFRONT COMMERCIAL DEVELOPMENT AND CONSTRUCTION MORATORIUM

Council Member\_\_\_\_\_, offered the following resolution and moved for its adoption, seconded by Council Member :

#### RECITALS

WHEREAS, the City of Saugatuck has enacted a temporary moratorium, through the adoption of Ordinances No. 230612-A and No. 230322-B (collectively, the "Moratorium"), on Waterfront Commercial Development and Construction within the City, which includes among other things new site developments including parking and site improvements, new building construction, and existing building expansion in the Waterfront Commercial Temporary Moratorium Area, as defined in the Moratorium;

WHEREAS, the Moratorium was enacted to provide the City with time study its zoning regulations and temporarily stop permitting, consideration, and construction within the Waterfront Commercial Temporary Moratorium Area to ensure the City can adequately develop land use regulations to protect the public health, safety, and general welfare of the City and its residents;

WHEREAS, the City has initiated the process of reviewing its zoning ordinance and revising regulations applicable to the Waterfront Commercial Temporary Moratorium Area to ensure that commercial waterfront development within the City will be regulated in an appropriate manner that protects the City's waterways, natural resources, and economic land uses;

WHEREAS, Section 2 of Ordinance No. 230612-A and Section 2 of Ordinance No. No. 230322-B provide that the City Council may extend the Moratorium by resolution from time-totime to finish adopting new regulations governing uses in the Waterfront Commercial Temporary Moratorium Area;

WHEREAS, the City Council previously adopted Resolution 230911-A extending the Moratorium through December 31, 2023;

WHEREAS, draft land use regulations governing uses in the Waterfront Commercial Temporary Moratorium Area have been presented to the City Planning Commission, and the Planning Commission has held a public hearing on the same, but the Planning Commission requires additional time to finalize these regulations, which must still be presented to and approved by the City Council before becoming effective; and

WHEREAS, the City of Saugatuck desires to extend the Moratorium through March 31, 2024, to ensure that it has sufficient time to adopt new regulations governing uses in the Waterfront Commercial Temporary Moratorium Area.

NOW, THEREFORE, BE IT RESOLVED that:

The City Council hereby extends the existing Moratorium imposed by Ordinances No. 1. 230612-A and No. 230322-B on the permitting, accepting applications, approvals, and consideration of new site development including parking and site improvements, new building construction and existing building expansion in the Waterfront Commercial Temporary Moratorium Area under Michigan law until March 31, 2024, or an earlier time in which the City adopts new regulations governing uses in the Waterfront Commercial Temporary Moratorium Area and rescinds the Moratorium.

2. The City Council may further extend the Moratorium by resolution from time-to-time to finish adopting new regulations governing uses in the Waterfront Commercial Temporary Moratorium Area.

3. All resolutions and parts of resolutions in conflict herewith are, to the extent of such conflict, repealed.

SUBJECT:	Short-Term Rental Enforcement Discussion

# **DESCRIPTION:**

The City's STR Task Force met for several months and finalized its report at the end of September. The Task Force report was presented to the Planning Commission on October 19 and to the City Council on November 8.

Survey results and public comments to the Task Force showed a desire for increased or better enforcement of short-term rental regulations and nuisance related issues such as noise and trash. The Task Force made several recommendations regarding enforcement which are attached.

Staff is seeking direction from Council on what it desires for short-term rental enforcement. Some questions for Council include:

- What problems are we trying to solve?
- What items should enforcement be focused on?
- Is the Council open to third party support and/or extra staffing to increase short-term rental enforcement?
- Does Council wish for staff to evaluate charging STR owners the cost of increased enforcement through possible fee increases?

Based on Council feedback, staff will proceed with developing a plan for enforcement, evaluating costs, and how to pay for any increased costs.

# Recommendations

# Good Neighbor Guide

A good neighbor guide sets expectations and regulations for those who rent a home within the Saugatuck area. Such a guide helps ensure residents' quiet and peaceful enjoyment of their neighborhoods. The Task Force has discussed the need to adopt a city wide "good neighbor guide." Provisions could include:

- Noise considerations
- Trash disposal
- Parking considerations-off-street versus on-street parking
- Owner/Operator of the short-term rental post the occupancy limits as established by the Township Fire Authority.

#### Noise

Noise is a common concern that has been raised since the Task Force began meeting in May of 2023 to discuss short-term rentals. As such, the following recommendations are put forth for consideration.

**Recommendation #1:** Request that City Council review the existing noise ordinance (Section 94.04) to determine if increasing the time of "quiet" hours is appropriate. A partnership with the Allegan County Sheriff's office may be appropriate in review of the noise ordinance.

**Recommendation #2:** Request that the Planning Commission encourage City Council to review the ability to create a noise ordinance for residential districts. Such an ordinance may limit the hours of operation for activities as construction, sound amplifiers, radio and musical instruments. This review would seek to enhance the existing city-wide noise ordinance to aid in further protecting residential districts.



#### **Fire Safety**

The Saugatuck Township Fire District presented recommendations to the Task Force regarding life safety improvements as it pertains to short-term rentals. The following recommendations are provided:

**Recommendation #1:** Request that the Saugatuck Fire Department transition to annual inspections of short-term rental units.

**Recommendation #2:** Explore reducing the occupancy limits that aligns more with single-family residential dwellings. Such reduced occupancy would entail allowing two (2) persons per bedroom, with a maximum of 12 persons per dwelling.

**Recommendation #3:** Encourage collaboration between the City of Saugatuck, the City of the Village of Douglas and Saugatuck Township to ensure rental ordinances, fee structures and programs mirror each other.

**Recommendation #4:** Explore requiring a local agent or management company to be located within 15 road miles of the short-term rental property. Such local agent or management company shall be knowledgeable about the property and accountable for responding to the property 24-hours a day, 7 days a week, 365 days a year.

**Recommendation #5:** Encourage regulating short-term and long-term rentals identically [in a similar manner].

**Recommendation #6:** Require the short-term rental certificate to be posted in a window visible from the public roadway in order to identify the property as having been issued a permit to operate as an STR.

**Recommendation #7:** Encourage the review of assessing monetary fines/fees to property owners who are in violation of the short-term rental ordinance and Saugatuck Township Fire District requirements. Such fines/fees would be tracked in an enforcement database.

**Recommendation #8:** Review the existing Fire District fee structure and recommend amendments where applicable.

**Recommendation #9:** Require documentation from the short-term rental property insurance company identifying and acknowledging the property is insured as a rental dwelling.

**Recommendation #10:** Acknowledge that the short-term rental properties were originally built and issued certificates of occupancy as "single-family dwellings" under the Michigan Residential Code. Renting a single-family dwelling to the public on a transient basis mirrors a commercial or business-like change-of-use that can trigger other requirements.

#### Trash

The Task Force has heard from citizens, residents and community stakeholders regarding a buildup of trash and general refuse that accumulates near short-term rentals. Residents believe short-term rentals are increasing the amount of discarded items above and beyond what is witnessed from non-short-term rental properties. The following items are recommended for consideration:

**Recommendation #1:** Encourage the Planning Commission to explore modifying the short-term rental ordinance (Section 154.022.V.) to require all short-term rentals— certified—to have an additional residential dumpster for every four (4) persons of occupancy. Example—if a STR has an occupancy limit of eight (8) persons, two containers shall be required. If an STR has an occupancy limit of 10 persons, three (3) containers would be required.

**Recommendation #2:** Encourage City Administration to review the existing trash and recycling policies to determine if additional pickups from the waste-hauler are warranted.

**Recommendation #3:** Encourage City Administration to review increasing the recycling pickup from once-a-month to twice-a-month to reduce the buildup of materials on residential properties.

**Recommendation #4:** Encourage City Administration to review the existing recycling policy and determine if additional pickups in the peak tourist months (May to September) are feasible with the waste management company.

# **Compliance Officer**

The Task Force has heard months of public comment and engaged with stakeholders who have expressed the need to have a dedicated code enforcement officer on staff to deal with concerns arising from short-term rentals. The following are offered for consideration:

**Recommendation #1:** Encourage the City Administration to explore hiring a dedicated code enforcement/code compliance officer to address short-term rental concerns. Such staff members would be able to respond to resident comments arising from noise, trash, occupancy and other ordinance violations.

# **General Modifications**

The following recommendations are general comments and directions that the Task Force has explored. These recommendations are broad in nature and are not specific to any one category:

**Recommendation #1:** Encourage the creation of a short-term rental registration public database in which the property owner and management company (if applicable) contact information is made available. Such contact information can be a general number, but one in which concerned residents can reasonably be expected to reach an agent or representative of the property.



**Recommendation #2:** Encourage the creation of a general call-line in which residents may leave non-time-sensitive concerns with city officials regarding short-term rentals.

**Recommendation #3:** Encourage the City Administration to review areas within residential districts in which "no parking this side of the street" signs could be installed to aid in emergency services access. This could be dedicated north/south roadways and east/west roadways to offer an emergency service pathway.

**Recommendation #4:** Encourage City Administration to review the ability to revoke a certificate for a short-term rental if multiple complaints are validated within a 12-month period. Further, encourage such a review to establish what is classified as a violation and the documentation process to the property owner to inform of the validated violation complaint.

**Recommendation #5:** Request that City Administration review the feasibility of requiring short-term rental properties to post their certificate numbers when listing the rental on popular platforms, such as AirBnB and VRBO.

**Recommendation #6:** Request that City Administration explore hiring a third-party agency to support the City in managing its short-term rental program.

#### **Residential Caps**

The Task Force has heard from residents, stakeholders and members of the community at large on the topic of instituting a cap on the number of short-term rentals. The following analysis is provided as it pertains to instituting caps on the number of short-term rentals within the City of Saugatuck.



# Task Force Discussion On Short-Term Rental Caps

The City of Saugatuck Short-Term Rental Task Force discussed the above potential policies in detail during a public meeting in September 2023. The task force does not support a city-wide cap (limit) on short-term rentals or a lottery. Some members of the Task Force felt strongly about seeking to impose a cap (limit) on the number of short-term rentals within residential zones or neighborhoods within the City. Other members opinioned that placing such a cap would not have the anticipated outcome that may be expected. Members felt that placing a cap on the number of rentals would not address concerns with noise, debris, parking and occupancy loads within residential dwellings.

In the discussion of caps, task force members did not agree about whether the views of part-time residents should carry as much weight as those of full-time residents. The task force also stressed the importance of involving legal counsel in any decisions made about caps.

The Task Force discussed placing caps on residential areas of the City to help alleviate the number of rentals in a given geographic area. The Task Force further discussed the potential for extreme challenges on establishing neighborhood districts for cap implementation. Some of the questions posed were as follows:

- Would such neighborhood caps be placed block by block?
- Would one side of a street be classified in one neighborhood, with the other side in a separate neighborhood?
- Would instituting a cap in residential neighborhoods then begin to push rentals into other areas of the city, thus exacerbating the issue and not solving for resident concerns regarding the number of rental units?

After discussion on the policies outlined above, the Task Force acknowledged that further review and analysis of instituting a cap on the number of rentals may be required. However, for the purpose of the Short-Term Rental Task Force, a consensus from the members was given that no definitive direction on caps was achieved. The Task Force acknowledged the amount of work and level of data analysis that was conducted since May 2023 and that continued discussions pertaining to caps should continue.

The Task Force found a consensus among members that addressing the initial concerns pertaining to noise, trash and occupancy from an enforcement perspective should be a top priority for the City Administration moving forward. The Task Force opinioned that by enforcing the existing regulations, while reviewing the recommendations provided within this report, would be beneficial to both residents and stakeholders in the community.

SUBJECT:	Authorizing Planning Commission to make Police-Powers Ordinance Recommendations for Short-Term Rentals

# **DESCRIPTION:**

The City's STR Task Force met for several months and finalized its report at the end of September. The Task Force report was presented to the Planning Commission on October 19 and to the City Council on November 8. The Task Force made several recommendations. Some recommendations may relate to the zoning ordinance, but staff believes many recommendations may be more appropriate for a police-powers ordinance.

A zoning ordinance generally regulates the use of land by district whereas a police-powers ordinance typically regulates licensing and activities on a City-wide basis. The Michigan Zoning Enabling Act grants the Planning Commission the authority to make recommendations on a zoning ordinance. Historically, the City Council has also deferred to the Planning Commission for recommendations on some police-powers ordinances as well.

While the land use of short-term rentals is appropriately included in the zoning ordinance, registration of short-term rentals and regulation of their activities are currently entirely in the zoning ordinance as well and may be better suited to a police-powers ordinance. Staff would like to work with the Planning Commission to review the current ordinances and Task Force recommendations and develop recommendations to Council for both zoning and police-power ordinances regulating short-term rentals. In order for the Planning Commission to make a recommendation on a police-powers ordinance, staff is seeking City Council approval for them to do so.

# INTERGOVERNMENTAL AGREEMENT TO RETAIN ENGINEERING SERVICES FOR PHASE 2 THE NORTH SECTION OF THE BLUE STAR TRAIL

This INTERLOCAL AGREEMENT is entered into pursuant to Act 7 of PA 1967 (hereinafter defined), by and among Saugatuck Township, 3461 Blue Star Hwy. P.O. Box 100, Saugatuck, MI 49453, the City of Saugatuck, 102 Butler St., Saugatuck, MI 49453, and the City of the Village of Douglas, PO Box 757, 86 W. Center St., Douglas MI 49406-0757 (the "Municipalities"), each of them a "public agency" as defined in Act 7.

# <u>RECITALS</u>

WHEREAS, the Friends of the Blue Star Trail (FOTBST) is a 501(c)(3) non-profit organization incorporated in the State of Michigan for the charitable purpose of advocating for the development and continuance of the Blue Star Trail from South Haven to Saugatuck ("Trail"); and

WHEREAS the Urban Cooperation Act of 1967, Act No. 7 of the Public Acts of Michigan, 1967, Ex. Sess., MCL 124.501 et seq. ("Act 7"), permits a public agency to exercise jointly with any other public agency any power, privilege, or authority which such public agencies share in common and which each might exercise separately; and

WHEREAS the Municipalities have supported the Trail and in 2019-20 each passed a Joint Resolution that reaffirmed their support for the Trail and for pursuing construction of the Trail through their territories (the "Project"), including creation of a Joint Tri-community Study Committee ("TCC"); and

WHEREAS the Municipalities desire to enter into an interlocal agreement, pursuant to Act 7, to jointly pursue the Project through the authority granted by Act 7.

WHEREAS each Municipality has the power, privilege and authority to perform various economic development and recreational activities and administrative functions supportive of economic development and recreational activities, and to enter into this Agreement.

WHEREAS the TCC has determined that it is necessary to retain the services of a professional engineering firm to advise it as to how best to proceed with the Project; and

WHEREAS the TCC identified a number of qualified engineering firms, obtained proposals from four firms, selected two finalists, checked their references, conducted interviews of the firms, selected Capital Consultants, Inc. ("C2AE"), and arranged for legal counsel to negotiate the form of a proposed contract with that firm; and

WHEREAS the parties and the FOTBST have agreed to pay the reasonable fees of C2AE related to the Project as set forth below; and

WHEREAS C2AE has provided a proposal for the Phase 2 engineering work for the Project and the Municipalities and the FOTBST desire to retain C2AE to complete Phase 2 engineering; and

WHEREAS each Municipality, pursuant to resolution of its governing body, is authorized to execute and deliver this Agreement.

# CORE TERMS

NOW, THEREFORE, the parties agree as follows:

- 1. The Municipalities will all execute the phase 2 contract, attached, at a meeting of their respective governing body.
- 2. To minimize costs and the risk of miscommunication, the parties hereby designate Ryan Heise, Saugatuck City Manager, as their liaison for the project (the "Project Liaison"). The Project Liaison shall be principal contact for the engineering firm. The Project Liaison shall provide regular status reports on the project to the Project/Advisory Team, which consists of representatives of each municipality and the FOTBST. Further, the Project Liaison shall consult with the chief administrative officer (i.e. the municipal manager) for the municipality before making any material decisions regarding the design of a trail segment located in that municipality.
- 3. Any changes in the scope of work to be provided by C2AE under this contract must be approved in writing by the Project Liaison, in consultation with the Project/Advisory Team and the chief administrative officer for each municipality in which the affected portion of the trial is located. Further, each municipality is free to retain C2AE or another individual or entity to render additional services to it under a separate agreement.
- 4. The Municipalities and FOTBST agree to share in payment of C2AE's fees as follows:

In addition, the Township has agreed to pay the fee for the archeological consultant to perform the services required by MDOT within the boundaries of the Township.

- 5. The parties expect to follow these procedures for dealing with C2AE's fees (6-12):
- 6. C2AE will break down its work into appropriate segments.
- 7. Prior to beginning work on the next segment, C2AE will provide a not-to-exceed estimate of its fee to the Project Liaison and to the FOTBST.
- 8. The Allegan County Community Foundation, as fiduciary to the FOTBST, will confirm in writing to the Project Liaison that it has sufficient funds on account to pay the fee for Phase 2.
- 9. The Project Liaison will authorize C2AE to commence work on the next segment absent an objection by a Municipality. Municipalities shall have ten (10) working days to object/challenge the scope of work/estimate prior to the start of each segment.
- 10. C2AE will issue monthly invoices according to the terms of its contract.
- 11. Upon approval by the Project Liaison and the FOTBST, the FOTBST will authorize the ACCF to pay the invoice from the FOTBST's account [or from a new account to be set up dedicated to the TCC Project].
- 12. Subject to the terms of the contract with C2AE, the Project Liaison, in consultation with the Project/Advisory Team, may determine to suspend or halt the work of C2AE at any time.

# MISCELLANEOUS

- 13. Entire Agreement. This Agreement sets forth the entire agreement between the Parties and supersedes any and all prior agreements or understandings between them in any way related to the subject matter hereof. It is further understood and agreed that the terms and conditions herein are contractual and are not a mere recital and that there are no other agreements, understandings, contracts, or representations between the Parties in any way related to the subject matter hereof, except as expressly stated herein.
- 14. No Presumption. This Agreement shall be construed without regard to any presumption or other rule requiring construction against the Party causing this Agreement to be drafted.

- 15. Severability of Provisions. If any provision of this Agreement, or its application to any Person or circumstance, is invalid or unenforceable, the remainder of this Agreement and the application of that provision to other Persons or circumstances is not affected but will be enforced to the extent permitted by law.
- 16. Governing Law. This Agreement is made and entered into in the State of Michigan and shall in all respects be interpreted, enforced and governed under the laws of the State of Michigan without regard to the doctrine of conflict of laws. The language of all parts of this Agreement shall in all cases be construed as a whole according to its fair meaning, and not construed strictly for or against any Party.
- 17. Captions. The captions, headings, and titles in this Agreement are intended for the convenience of the reader and not intended to have any substantive meaning and are not to be interpreted as part of this Agreement. They are solely for convenience of reference and do not affect this Agreement's interpretation.
- 18. Terminology. All terms and words used in this Agreement, regardless of the number or gender in which they are used, are deemed to include any other number and any other gender as the context may require.
- 19. Cross-References. References in this Agreement to any Article include all Sections, subsections, and paragraphs in the Article; references in this Agreement to any Section include all subsections and paragraphs in the Section.
- 20. Jurisdiction and Venue. In the event of any dispute between the Parties over the meaning, interpretation or implementation of the terms, covenants or conditions of this Agreement, the matter under dispute, unless resolved between the parties, shall be submitted to the courts of the State of Michigan.
- 21. Amendment. The Agreement may be amended or an alternative form of the Agreement adopted only upon written agreement of all Parties. In the event that an amendment to this Agreement or alternative form of Agreement is approved by less than all Parties, any Party which has not approved of the amendment or alternative form of Agreement may withdraw from the Agreement.
- 22. Execution of Agreement; Counterparts. Each Party shall duly execute three (3) counterparts of this Agreement, each of which (taken together) is an original but all of which constitute one instrument.

# 2024 POVERTY RESOLUTION Resolution 231211-C

WHEREAS, the adoption of guidelines for poverty exemptions is within the purview of the City Council, and

WHEREAS, the homestead of persons who, in the judgment of the Supervisor and Council of Review, by reason of poverty, are unable to contribute to the public charges is eligible for exemption in whole or part from taxation under Public Act 390, 1994 (MCL 211.7u) and as amended by PA 620 of 2002 and further amended by PA 253 of 2020; and

WHEREAS, pursuant to PA 390, 1994, PA 620, 2002 and PA 253 of 2020, Saugatuck City, Allegan County adopts the following guidelines for the Board of Review to implement. The guidelines shall include but not be limited to the specific income and asset levels of the claimant and all persons residing in the household, including any property tax credit returns, filed in the immediately preceding year,

To be eligible, a person shall meet all the following requirements:

1) Be an owner of and occupy as a principal residence of the property for which an exemption is requested.

2) File a claim with the Supervisor, Assessor or Council of Review, accompanied by federal and state income tax returns **for all persons** residing in the homestead, including any property tax credit returns filed in the immediately preceding year UNLESS the attached affidavit is completed for each person that is not required by law to file Federal and/or State income tax return(s).

3) Produce a valid driver's license or other form of identification.

4) Produce a deed, land contract, or other evidence of ownership of the property for which an exemption is required, if requested.

5) Meet the federal poverty income standards as defined and determined annually by the United States Office of Management and Budget (see attached).

6) Have assets totaling no more than \$15,000, not including the primary residence.

7) The application for an exemption shall be filed after January 1, but before the day prior to the last day of Board of Review in the year that the exemption is being requested.

8) Any additional eligibility requirements allowed by law as determined by the City Council of Review.

**NOW, THEREFORE BE IT HEREBY RESOLVED** that the Board of Review shall follow the above stated policy and federal guidelines in granting or denying an exemption.






