CITY COUNCIL SPECIAL MEETING MINUTES *PROPOSED*June 22, 2022

Call to Order:

The meeting was called to order by Mayor Lewis at 4:00 p.m.

Attendance:

New Business:

A. Saugatuck Township Fire District – FY 22-23 Budget:

FY 22/23 Saugatuck Township Fire District (STFD) budget for the City Council review. The STFD has scheduled the required public hearing on June 20, 2022, at 4pm. Each of the three (3) participating governmental units in the District is required to approve the operating budget annually prior to the public hearing and adoption by the STFD Administrative Board.

Motion by Trester, second by Bekken, to approve the Saugatuck Township Fire District FY 22/23 Budget as presented. Upon roll call vote, motion carried unanimously.

B. <u>The Mayor's appointment for the Zoning Board of Appeals positions as</u> follows:

The reappointment of James Muir with said term expiring July 1, 2025.

The appointment of Richard Crawford with said term expiring July 1, 2025.

The alternate reappointment of Jim Hundreiser with said term expiring July 1, 2025.

Motion by Stanton, second by Leo, to approve the Mayor's appointments as presented. Upon voice vote, motion was carried unanimously.

C. The Mayor's appointment for the Planning Commission positions are as follows:

The reappointment of Richard Heriford with said term expiring July 1, 2025. The appointment of Mark LaChey with said term expiring July 1, 2025.

Motion by Leo, second by Gardner, to approve the Mayor's appointments as presented. Upon voice vote, motion was carried unanimously.

D. Request for Council to support City Manager (in conjunction with Mayor Lewis) decision to provide Oval Beach passes to all City Staff:

In early June, City Manager Heise made an executive decision to issue all City staff Oval Beach passes, one (1) per employee. Operating under the logic of expressing gratitude to employees and allowing staff to enjoy the assets they work hard to maintain. After his decision, he was made aware of a 2010 policy that required City Council to approve "complementary beach passes." He also approved a beach pass for a Hope College Professor, who continues to study our critical sand dune area with her students. Additionally, he would not be opposed to offering passes to all fulltime contracted employees (limited number of engineers, attorneys, and police) in additional to Council. It's his belief that we should encourage people that service our community to enjoy it after hours and weekends as it provides a unique perspective on operations.

Motion by Leo, second by Stanton, to approve the motion as described in the description to include our first responders and at the City Manager's discretion. Upon roll call vote, motion carried 5-2. Yeas- Dean, Leo, Lewis, Stanton & Trester. Nays- Bekken & Gardner.

E. Resolution No. 220627-C (PA 152 Compliance):

The Michigan Department of Transportation requires certification of compliance with PA 152 in order to receive Michigan Transportation Fund payments. The Michigan legislature in 2011 adopted Act No.152 which regulates municipal employee benefit expenditures. Under the Act, communities are given the option to exempt itself of the requirements of the Act for compliance.

Motion by Trester, second by Leo, to approve Resolution No. 220627-C as presented. Upon roll call vote, motion carried unanimously.

F. Capital Improvement Budget:

City Manager Heise compiled a list highlighting the priorities Council set forth at their strategic planning session that took place in December 2021. Many of the priorities are administrative in nature and do not require a specific budget allocation as a capital improvement. Please note that staff and Council will adhere to purchasing procedures set forth in the Charter, and that any unspent funds will return to fund balance (reserves) at year end, 2023. He included the remainder of the lower priority goals set at the planning session as a refresher. Total recommended budget allocation for improvements is recommended at \$1,000,000.00. No action by Council.

Public Comment:

- Dale Harrison, Saugatuck Township resident- spoke regarding opposition to previous meeting agenda item of Bridge Street City water hook up.
- Dan Fox, City of Saugatuck resident- spoke highly of Richard Crawford's time on the Planning Commission and offered as in the past to consulting as Chairman on appointments of the Planning Commission.

New Business:

A. Resolution 220627-A (FY 21/22 Year-End Budget Amendments):

The City Council is authorized by statute to amend the budget throughout the fiscal year as it becomes apparent that a deviation from the original general appropriations

act is necessary. Attached is the recommended budget amendment for fiscal year 2022.

Motion by Gardner, second by Leo, to approve Resolution 220613-A to approve Resolution 220627-A amending the FY 21/22 budget as presented. Upon roll call vote, motion carried 6-0.

B. <u>RESOLUTION NO. 220627-B (General Appropriations Act):</u>

WHEREAS, pursuant to the Uniform Budgeting and Accounting Act, P.A. 2 of 1968, as amended, (the "Act") local units of government are required to pass a general appropriations act; and WHEREAS, in accordance with the Act, the City

has provided the required notice and hearing; and WHEREAS, in order to comply with the Act, the City wishes to adopt an appropriations act pursuant to this resolution.

Motion by Gardner, second by Leo, to approve Resolution 220627-B General Appropriations Act. Upon roll call vote, motion carried 6-0.

C. Bridge Street Utilities:

City staff has been adhering to policies that require properties (new construction) connect to municipal water, as a result of new construction on Bridge Street. A significant amount of staff, engineering and legal time has been placed into researching policy, previous assessment methodologies, road/property surveys and communicating with homeowners regarding the city policy. I've attached the engineer's summary- cost for road improvements and the water extension, in addition to assessment options for Council to decide upon.

Motion by Trester, Second by Gardner to allow an exemption to all property owners to connect to municipal water and install a private well. Upon roll call vote, motion carried 6-0.

Public Comment:

 Dale Harrison, Saugatuck Township Resident- spoke in favor of allowing an exemption to Bridge Street property owners to connect to municipal water and install a private well.

Boards, Commissions & Committee Reports:

- Councilmember Gardner- Updated Council on the next planning commission meeting.
- Mayor Lewis- Updated Council on Tri-Community Recycling Committee meeting.
 They also had a successful Styrofoam collection event.

Council Comments:

- Councilmember Trester- updated Council on recent Kalamazoo Lake Harbor Authority meeting. From a recent study of sediment deposits on the bottom of the lake, there are no or minor risk of PCB exposure from lake sediments in our harbor. There was also a surface water analysis and found likewise that since 2014, no PCBs detected in Kalamazoo River water. The Harbor Authority has been interested in mounting stick lights on the Blue Star Highway Bridge. Total budget is about \$12,000, Douglas and Township have agreed to participate in funding, and they will be asking the City as well.
- Councilmember Bekken- updated Council on recent Kalamazoo Lake Sewer and Water Authority Board. All audits are in progress. KLSWA signed a contract with plumbers to complete about \$30,000 of sewer repairs. They have moved into phase two of their regenerator project, they have four operational portable generators. He also reviewed work to be completed in the future with lift

- stations in the City.
- Councilmember Leo- updated Council on Non-Motorized Bike Trail; they were invited to present to the Michigan Trust Fund. There were a handful of residents, the Mayor of Douglas and representatives of the Friends of the Blue Star Trail that spoke in favor of the trail. There is no announcement yet on the decision of the grant.
- Councilmember Gardner- Thanked Councilman Bekken and KLSWA for all their work and service. He updated Council on Planning Commission; they have begun working on their strategic planning goals along with some housekeeping. He also welcomed new member Mark LaChey.
- Councilmember Dean- Complimented the staff on running the City really well. He is pleased with everything he is seeing in town, he thanked staff.

Mayor's Comments:

Mayor Lewis updated Council on the Tri-Community Recycling Committee; she
will have the final report to Council at the beginning of July and they will be
holding a second Styrofoam collection the 24th of September.

Adjournment: Motion by Trester, second by Dean to adjourn, Mayor Lewis adjourned at 7:55 p.m.

City Managers Report –Highlights July 11, 2022

City Hall Exterior Repairs

Kate White and Scott Herbert, along with the assistance of our city engineering firm are in the process of developing a scope of work for exterior repairs to City Hall. Basic scope includes scrape and paint existing wood (replacing rotten pieces as needed, gutter repairs, replacing flower boxes, exterior stairway repairs as needed. Bids will be solicited and a review by the Historical Commission will also be included.

4th of July Parade

Numerous positive responses received for the well-managed 4th of July parade. Thank you to the many volunteers who assisted with the successful event.

Pavement Management Plan

Staff met with the City Engineer, work on a five-year pavement management plan being developed.

Estimated timeline:

- Update the PASER study in July
- Meet with staff in August to develop priority list
- Develop cost estimates for priority projects and draft CIP in September
- Review with council in October and finalize based on feedback

Oval Beach Staffing and operations

Staff did a fantastic job managing a very busy beach weekend. Congratulations to the DPW and Beach Crew. Compliments keep rolling-in regarding Beach Staff with their attention to trash and overall management.

Blue Star Trail Update

Transportation Alternatives Program (TAP) grant has been submitted, along with state trust fund grant application. We are looking forward to good news soon on the TAP grant. Township and City Managers will be coordinating next steps. Meeting scheduled for Tuesday the 12th with

engineers, Township Manager, Friends of the Blue Star Trail and other stakeholders.

Road resurfacing (and utility) projects

Campbell Road —Note from engineer- Top course paving is anticipated the week of July 11. The road will remain closed to through traffic after the paving work until the project is complete. It will be tempting to drive normal speeds at that point, but please use caution as the contractor finishes up the final work items. One final note — please review any work that was done on your property, especially work done inside the house for those that are applicable, and let us know if there are outstanding items that still need to be addressed — landscaping or irrigation repairs, interior plumbing items, etc. We will review those items and incorporate them in our final list for the contractor as appropriate. Thanks once again for your continued patience!

Dune Ridge Waterfront Update

Litigation continues... there are three (3) pending legal cases related to the subject parcel along the waterfront. A significant amount of staff time is being dedicated to facilitating the litigation process.

Kalamazoo Lake Sewer and Water (KLSWA) Agreement

City/Township Managers continue to discuss the Assessment Management Plan, along with our respective attorneys and engineers.

KLSWA prefers to begin with negotiating the asset management plan for sewer to utilize as a roadmap for the water agreement. Legal counsel has been engaged and provided initial comments. Local municipal managers will continue to meet and discuss.

- Lt. Ensfield and his team continue to plan for upcoming special events, with Venetian Festival being the next big event.

City of Saugatuck Status Report of Engineering Activities July 7, 2022

General Consultation

- Water Street Sidewalk: Finalized plans based on input from the property owner. The property owner is preparing for construction in September (canceling bookings, arranging vacation, etc.).
 Based on the anticipated project cost, this should likely be a formal public bidding vs. obtaining several quotes. We can prepare a bid package as soon as the City is ready to proceed (ongoing discussion regarding property owner cost participation).
- High School Improvements: Water main construction work is nearly complete. Providing assistance on an as-needed basis.
- Water Street Water Services: We reviewed options for the water services at 403-449 Water Street (4 properties on a shared service that appears to run under several of the buildings) and prepared a summary memo recommending that these be included in the City's overall water system asset management planning. A draft proposal has been prepared for discussion.
- Olde Mill Apartments Water Service: We have received two of three quotes we are expecting to replace the water service to 720 N. Maple Street, as it appears to be currently connected to the private water main for the Olde Mill Apartments complex. We will be discussing cost sharing options in the near future.
- Takken Street Repairs: We are assisting the DPW in obtaining quotes to repair underdrain and pavement at the intersection of Mason & Takken Streets.
- City Hall Renovations: We will be assisting City staff with preparing an RFP for exterior building improvements.

Campbell Road Improvements

- Base course paving is complete.
- Grass restoration, drive approaches and other work is ongoing to prepare for top course paving, which is anticipated to be the week of July 11.
- The Substantial Completion date in the contract was May 26. Liquidated damages are being imposed starting May 27 per the contract to cover the Cities' hard and soft costs for the schedule overrun.

Bridge Street Water Main Extension

• We have notified the low bidder that this project will not be proceeding to construction.

Maple Street Improvements

- Met with the affected property owner to review the options in the draft drainage study.
- We will finalize the study once feedback is received for council consideration.



Road Project Planning

- We met with City staff on June 1 to review the draft plan.
 We submitted the application for the MDOT Category B program and should hear whether we received funding later this summer.
- We are in the process of updating the 2019 PASER study and will then develop a draft Capital Improvements Plan for council consideration.

DESCRIPTION:

John Kerr, on behalf of the Saugatuck Douglas History Center has submitted a request for City Council to waive the prohibition for a wind feather sign at the Pump House Museum at 735 Park Street.

The relevant sections of Chapter 150.30 state in part:

"(2) Pennants, feather flag signs, windfeather signs, and portable signs as defined in § <u>154.140</u> of the Zoning Ordinance shall be prohibited;

And

- (H) Exceptions. City Council or a designee shall have the authority to waive any of the requirements of this section subject to the following:
 - (1) The sign does not create a traffic vision obstruction;
 - (2) The sign does not create a pedestrian traffic obstruction;
- (3) The sign is compatible with the surroundings and is not uniquely out of character for the community; and
- (4) The sign does not create a situation which could be detrimental to health, safety, or welfare."

The City Council may approve a windfeather sign as an exception.


Russ and Scott,

I would like to put an "OPEN" sign in front of the pump house so that people could see that our new Mount Baldhead exhibit is open when they're standing up in the garden area (where the new SCA installation is located). Many people walk away because the place doesn't look "open" from that vantage point and the only thing we have out front is an American flag.

The sign I purchased (see photo below) is a 5 foot tall feather flag, which I since learned is prohibited in Saugatuck. However, as stated below "City Council or a designee has the authority to waive this requirement" subject to certain criteria.

The sign would be placed along the patio directly in front of the entry door, only visible from the garden and passing boats. It does not create any obstruction to traffic vision or pedestrian traffic. In my opinion it is compatible with the surroundings (in front of a small museum/gift shop with no other business or residences nearby). And it does not create a situation which could be detrimental to health, safety, or welfare.

The sign would be on display only during business hours - Friday, Saturday, and Sunday noon - 4pm (or 12 hours per week).


